Memorandum of Understanding
between
IUPAT District Council 15 ("Union")
and

Western Wall and Ceiling Contractors Association, Nevada Chapter ("Association")

In recognition of the continued economic distress that exists in the Southern Nevada construction market, the parties have agreed to modify the terms and conditions of the Southern Nevada Painters and Decorators Master Agreement as follows:

1. A one (1) year extension to the existing Agreement, which will establish a new expiration date of June 30, 2014.
2. The Union has accepted minor economic increases specifically for maintenance of benefits. The remaining \$.93 of the July 1, 2011 increase is diverted until July 1, 2013. The parties did not modify the next scheduled increase of \$2.09 on July 1, 2012.
3. The parties agree to decrease the contribution to the JCIP fund by \$.05 per hour and divert it to the JC fund.
4. The parties agree to decrease the contribution to the JATC fund by \$.03 per hour to \$.39 per hour and divert it to the HSUTAP fund for the purpose of funding training expenses which increases the contribution for the fund to \$.16 per hour.
5. The parties agree that the attached wage and benefit schedule shall be in effect from July 1, 2011 through June 30, 2014.
