RE: May 1, 2020 Allocation – Colorado AGC Statewide Building Construction Master Agreement

Effective May 1, 2020, there will be a one dollar and twenty-five cent (\$1.25) increase. Seventy-five cents (\$0.75) will be allocated to Wages, twenty-five cents (\$0.25) to Health and Welfare and twenty-five cents (\$0.25) to Pension. Per the Bylaws, three cents (\$0.03) of the wage increase will be applied to Supplemental Dues, which is deducted from the hourly wage.
